

Treasurer's Report December 31, 2016

At the end of 2016 Regency's net operating cash was \$74,000.
Our reserve assets totaled \$1,046,000.

The year-end annual surplus was \$64,000 and has been carried over to 2017 to reduce budgeted quarterly maintenance payments by offsetting higher operating costs from the Country Club and Comcast.
