

## Treasurer's Report

### October 31, 2016

At the end of October Regency's net operating cash was \$268,000.  
Our reserve assets totaled \$1,046,000.

A surplus of approximately \$60,000 is anticipated at year-end and will be carried into 2017 to partially offset higher operating costs next year from the Country Club and Comcast.
